To prevent or correct nutrient deficiencies, apply GRIGG A-O-K as a foliar spray early in the morning or late afternoon. Allow 3-6 hours for drying time before irrigation. Best to apply after mowing.

*Cool Season Grasses:* Apply 3-6 fl oz per 1,000 sq ft or 1-2 gal per acre [10-20 L per hectare] as needed every 14 days.

*Warm Season Grasses:* Apply 2-6 fl oz per 1,000 sq ft or 0.75-2 gal per acre [7-20 L per hectare] as needed every 14 days.
