To prevent or correct nutrient deficiencies, apply GRIGG TURF RALLY (NO PHOS) after mowing and water in thoroughly after application to help speed up breakdown. DO NOT drag this product into aeration holes. DO NOT apply to wet turf.

General Maintenance of Cool and Warm Season Grasses: Apply 3-6 lb per 1,000 sq ft or 131-261 lb per acre [1.5-3 kg per 100 sq m or 146-292 kg per hectare] as needed.

This product will increase turfgrass uniformity, vigor and color after establishment or for existing turfgrass swards. Make frequent applications at lower rates, or apply higher rates for greater plant demand. Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

This product is not intended for use on food crop sites.
