General Maintenance of Cool and Warm Season Grasses: Apply 10-14 lb per 1,000 sq ft or 435-610 lb per acre [5-7 kg per 100 sq m or 488-684 kg per hectare] as needed.

Promote Plant Recovery: Use this product to increase turfgrass vigor and recovery from mechanical and/or environmental stress.
