GRIGG REZADONE breaks down thatch and black layer, and increases available nutrient uptake.

Turf (Sports Turf, Sod, Putting Greens, Fairways, lawns, etc.):

Thatch Management: Apply 12.8 fl oz per acre every 14-28 days until desired results are achieved.

Black Layer Management: Apply 5 fl oz per 1,000 sq. ft. and water in thoroughly. Make applications every 30 to 60 days until desired results are achieved.

MIXING AND HANDLING INSTRUCTIONS

Mix with water for a minimum total spray volume of 20 gallons per acre to ensure proper coverage. GRIGG REZADONE contains a strong surfactant load; it may be necessary to add additional defoamer, particularly for sprayers with heavy agitation. GRIGG REZADONE may be applied with most fertilizers, pesticides and plant growth regulators.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
